RECOMMENDATION

Approve the levying of assessments for unpaid administrative fees, citation fines costs, and abatements in the amounts listed for each property on the Administrative Citation Unpaid Fines Assessment List (ACUFAL).

SUMMARY

The Code Enforcement Division issued Administrative Fees and Citations on a number of properties. There are 236 properties that after appropriate notification, failed to correct the noted violation(s) by the time specified on the Notice of Violation and Administrative Citation. These properties were fined or abated. Although the property owners have been sent invoices for the outstanding fees, fines and abatements, the City has not yet received any payment.

In accordance with Sections 1.15.150 and 7.54.150 of the Vallejo Municipal Code, the Code Enforcement Division has prepared a list of unpaid administrative fees and citation fines. The Code Enforcement Division is requesting approval of property tax assessments to recover the costs of unpaid fines and abatements that are shown on the list.

BACKGROUND AND DISCUSSION

For years, the Code Enforcement Division has used the Notice of Violation, administrative citation and abatement actions to correct violations of the Vallejo Municipal Code on several properties. In each case, the administrative fees, abatement actions and/or fines take place after other attempts to have the property owner correct the violations have failed.

The property owners are sent invoices for administrative fees, citation fines and/or abatement costs. The Code Enforcement Division is requesting that the Beautification Advisory and Code Enforcement Commission approve assessment of the following properties, as the administrative citation fines have not been paid.

All affected property owners were notified of the assessment hearing by regular and certified mail at least (15) days prior to the hearing.

FISCAL IMPACT

These assessments are to recover unpaid administrative fees and fines and abatement activities owed to the City of Vallejo. Without property tax assessments, these fines are unlikely to be recovered voluntarily.

My parents are retired and their ages were 77 and 74 back then, their income is little and they asked my brother Jorge Oliveros to come to live with them so he could help them with the bills. Any violations that were done at that time I wasn't aware of it because my parents don't speak English and my brother was not giving me any mail much less any information about this situation. My brother was arrested and my parents moved to Sacramento. I wasn't able to come to the house during the day because I opened a small restaurant in Concord with a partner but my partner quit the business two months after opening; that left me with all the responsibility of the business and working 16 to 18 hrs. a day some days I slept in the restaurant because I was not going to have time to sleep if I came to Vallejo, I was living at 213 Cabrillo Dr. in Vallejo back then. The business was really bad, no income for me at all, no money to pay employees, the house was being destroyed and no money to fix it to rent it out. I called Sunrise tow co 925-917-4554. in Pittsburg, CA to come and tow all the vehicles that were in the house and disposed of them.

My son Jose de Jesus Madrigal moved in to the house and he was avoiding me because he was not paying me the rent agreed nor fixing the house, I don't know when all these violations happened; I had to evict my son because the house continued being destroyed, it took me a whole year to evict him because of money issues. Finally my business lease agreement expired so I closed the restaurant on April 15, 2013 and at the moment I'm unemployed looking for a job.

I'm attaching proof of the eviction, I didn't have written lease agreements on the house because of family situation, I didn't think it was necessary because were my parents and later my son.

I appreciate your time and attention to my case, I don't know my options.





I'm writing you for the appeal of my Notice of Violation.

I have left a voice message to my Code Enforcement Officer David Sidie that it had been raining during several weeks. I received the Notice of Violation: Painting the side of my house.

I told him and the Code Enforcement Officer before him that I'll paint it when the raining season is over. I said that I'll paint it on May 15, but the work was a lot after I pressure washed the side of the house that was to be painted.

After further review of the house, I saw that it could take a little bit more work prepping it such as taking more of the chipped paint and sanding it where needed.

Also, it rained for a few days on May 26 to 27 and sprinkled lightly a week before.

I left a voice message to David Sidie on May 24 about my failure to start painting it on May 15 which I told him I would begin. But because of the large amount of work that I did not foresaw: the additional chipping of the paint and the rain and my work, I did not finish it.

I don't I have the means to pay for a hired painter at the moment. I'm appealing the violation and hope you listen to my concern.

Dear Mr. Sidie:

I am in receipt of two certified letters dated April 30, 2013, copies of which are attached for your easy reference. Please note I did not actually receive these letters until Saturday, May 18, 2013. It appears the post office left the certified letter form on Thursday, May 16 and I did not find it at the Russell Street address until the evening of Friday, May 17.

In any event, I would like an opportunity to explain the situation that occurred at 542 Russell Street which prompted the citations noted in your April 30 letters.

Initially I would like to state that I never saw or received any citations from the City of Vallejo. To explain, my nephew James Runyan was occupying the house. James is an extremely psychiatrically disabled young man. When I purchased the home it was to allow James a place to live since, because of his disability, he was unable to rent a place to live on his own. Initially when James moved into the home he was medication compliant; however, soon after he became non-compliant and was subsequently hospitalized. Upon discharge he was medication compliant for a brief period of time, then non-compliant again. Over the past two years James' condition decompensated. He became extremely paranoid, violent and destructive (as evidenced by the broken windows in the house). I tried and tried to get someone to intervene and get him hospitalized again. There were several calls to the police (by myself and I have found out recently from the neighbors as well), Adult Protective Services, etc., but I was unable to get him help. I made the decision (albeit admittedly not the correct decision) not to fix the damage to the house until I could get James removed from the house and hospitalized. While I

could I suppose have turned him out on the street, I chose not to because of his grave condition. In any event, I was ultimately able to get SCMH to do a home assessment and they deemed James to be gravely disabled and unable to care for himself. This occurred on February 28, 2013. James was 5150'd, placed under a temporary conservatorship and hospitalized for 28 day. He is currently living in a board and care home outside of Vallejo. He will not be returning to Russell Street.

On March 1, 2013 | began the clean-up of the house on Russell Street. All windows have been replaced or boarded up and all trash in and around the house has been removed.

As stated above, I was not previously aware of any citations having been issued for the house. I only happened to receive these latest certified letters because James is no longer in the house and I'm receiving the mail delivery now. Also, I am unsure of exactly what the citations were for, except that I would suspect they were for the state of the exterior of the house.

While I note in your letters that the time for "appeal" has expired, I would ask you to please reconsider the charges since I never received any of the citations. I don't disagree they were issued, I just didn't receive them given the above-noted circumstances.

I would welcome you to come for an inspection of the house to see for yourself that the house is being repaired and I can assure you this won't happen again.


