If comments come to the Beautification and Design Review Board without prior notice and are not listed on the AGENDA, no specific answers or response should be expected at this meeting per State law.

**Agenda Items:** Those wishing to address the Board on a scheduled agenda item should fill out a speaker card and give it to the Secretary. Speaker time limits for scheduled agenda items are five minutes for designated spokespersons for a group and three minutes for individuals.

**Notice of Availability of Public Records:** All public records relating to an open session item, which are not exempt from disclosure pursuant to the Public Records Act, that are distributed to a majority of the Beautification and Design Review Board will be available for public inspection at City Hall, 555 Santa Clara St., 2<sup>nd</sup> Floor, or the Vallejo Public Library, 505 Santa Clara St. at the same time that the public records are distributed or made available to the Beautification and Design Review Board. Such documents may also be available on the City of Vallejo website at www.ci.vallejo.ca.us subject to staff's ability to post the documents prior to the meeting.

**Disclosure Requirements:** Government Code Section 84308 (d) sets forth disclosure requirements which apply to persons who actively support or oppose projects in which they have a "financial interest", as that term is defined by the Political Reform Act of 1974. If you fall within that category, and if you (or your agent) have made a contribution of \$250 or more to any board member within the last twelve months to be used in a federal, state or local election, you must disclose the fact of that contribution in a statement to the Board.

Appeal Rights: The applicant or any party adversely affected by the decision of the Beautification and Design Review Board may, within ten days after the rendition of the decision of the Beautification and Design Review Board, appeal in writing to the City Council by filing a written appeal with the City Clerk. Such written appeal shall state the reason or reasons for the appeal and why the applicant believes he or she is adversely affected by the decision of the Beautification and Design Review Board. Such appeal shall not be timely filed unless it is actually received by the City Clerk or designee no later than the close of business on the tenth calendar day after the rendition of the decision of the Beautification and Design Review Board. If such date falls on a weekend or City holiday, then the deadline shall be extended until the next regular business day.

Notice of the appeal, including the date and time of the City Council's consideration of the appeal, shall be sent by the City Clerk to all property owners within two hundred or five hundred feet of the project boundary, whichever was the original notification boundary.

The Council may affirm, reverse or modify any decision of the Beautification and Design Review Board which is appealed. The Council may summarily reject any appeal upon determination that the appellant is not adversely affected by a decision under appeal.

If any party challenges the Beautification and Design Review Board's actions on any of the following items, they may be limited to raising only those issues they or someone else raised at the public hearing described in this agenda or in written correspondence delivered to the Secretary of the Beautification and Design Review Board.

#### 11. PUBLIC HEARING

A. Project Title: Planned Development Unit Plan PD #13-0005;

Minor Exception ME #13-0009

Applicant: Joseph Callahan Location: 200 Georgia St.

The applicant has proposed to construct a new office building and parking garage on the northeast corner of Georgia and Santa Clara Streets in downtown Vallejo. The project includes two levels of parking with 106 parking spaces, and two levels of office space totaling 34,600 square feet of floor area above the parking garage. The project involves demolition of the existing two-story Vallejo Housing Authority building and replacement of the pocket park adjacent to the building on Georgia Street as a linear extension of Unity Plaza.

The applicant has also requested an Exception from the Downtown Vallejo Specific Plan and Design Guidelines standards that require the building to be sited on the corner, to provide ground floor retail space along the Georgia Street frontage, and to provide a frontage with a pedestrian orientation along Santa Clara Street.

Proposed Environmental

Determination: The proposed project qualifies for a Class 32

Categorical Exemption (Infill Development), per Section 15332 of Title 14 of the California Code of

Regulations.

Staff Recommendation: Continue the public hearing to a study session at the

January 16, 2014 Special Beautification and Design

Review Board meeting.
