SUMMARY

On December 4, 2007, the Council adopted a two-year meeting schedule as required by Section 308 of the City of Vallejo Charter.

The meeting schedule presented on June 10 removed the third meeting for the months of July through December. The present schedule has reinstated the third meeting for the months of July, August, September, and October. It is staff's intention to use the third meeting for study sessions, commission interviews, etc. This meeting can be cancelled by resolution of the Council if necessary.

The meeting originally scheduled for Tuesday, November 4 has been removed because it is election day. A meeting is scheduled for Thursday, November 6, to fulfill the two meeting per month required by Section 308 of the City Charter.

The necessary revisions to the 2009 schedule will be done in December.
