**Disclosure Requirements:** Government Code Section 84308 (d) sets forth disclosure requirements which apply to persons who actively support or oppose projects in which they have a "financial interest", as that term is defined by the Political Reform Act of 1974. If you fall within that category, and if you (or your agent) have made a contribution of \$250 or more to any group member within the last twelve months to be used in a federal, state or local election, you must disclose the fact of that contribution in a statement to the group.

**Disability Accommodation:** Vallejo City Hall is ADA compliant. Devices for the hearing impaired are available from the City Clerk. Requests for disability related modifications or accommodations, aids or services may be made by a person with a disability to the City Clerk no less than 72 hours prior to the meeting as required by Section 202 of the Americans with Disabilities Act of 1990 and the federal rules and regulations adopted in implementation thereof.

SUBJECT: 2019-2020 ECONOMIC VITALITY COMMISSION (EVC) MEETING & ENGAGEMENT PLAN

The three purposes for the EVC are outlined as follows in the Vallejo Municipal Code Chapter 2.36:

- 1. To advise the city council on issues that can enhance job growth and increase private investment in Vallejo;
- 2. To review and assist with updates and the implementation of the economic development element of the general plan; and
- 3. To assist with business retention and attraction activities.

The following information is intended to describe anticipated EVC engagement, at meetings and through other activities, for the coming year. This meeting and engagement plan connects the EVC's codified purpose with specific policies, programs and initiatives under development or underway at the City or its partners. The aim is to substantive, timely and relevant avenues for EVC involvement and input that supports and contributes to the economic development efforts of the City and its partners.

#### Meeting Format

Staff is recommending the following format for future EVC meetings held in Council Chambers. Each meeting's agenda items would be comprised of two overarching components:

- 1. Regular updates on the following topics (ideally) to be presented at every meeting:
  - a. BRE Program Update
  - b. Sales Tax Summaries
  - c. Quarterly Summary of Development Activity
- 2. A particular topic of focus for the City's economic development efforts for that meeting. Sometimes this will be information only, but ideally it will timed either to elicit the Commission's feedback on policies or programs under development by the City or our partners or to receive the Commission's support in outreach activities related to a given topic and associated initiatives. Proposed focus topics are listed below, and may be subject to addition, subtraction or revision based on evolving nature of the City's economic development initiatives and partnerships.

#### Proposed Focus Topics

- 1. City Communications & Economic Development Marketing along with Opportunity Zone overview and rollout of the City's Opportunity Zones portal
- 2. Long-range planning efforts: Development Code Update, Review of Employment, Education & Training Chapter of the General Plan, Capital Improvement Program and regionally designated Priority Development Areas

Subject: 2019-2020 EVC MEETING & ENGAGEMENT PLAN

- 3. City's business and workforce development partners: Solano EDC, Workforce Investment Board & Solano Small Business Development Center SBDC
- 4. Development Process Improvements timed with rollout of City fee update, including overview of Chamber of Commerce Business Permitting Ad Hoc Committee
- 5. Tourism: Visit Vallejo, Six Flags and the City's transit occupancy tax
- 6. Downtown Update: Property & Business Improvement District (PBID), Downtown Events and Downtown Streetscape Improvement Project
- 7. Mare Island Update: business and employment development and new master planning effort
- 8. Higher Education Update: student enrollment and expansion plans
- 9. Transportation: Soltrans and WETA service updates and Solano Transportation Authority engagement

#### Other Activities

EVC would also take part in other activities, including:

- Business walks along the City's major corridors (with possible SBDC involvement to be confirmed)\*
- Business tours or 1-2 meetings/year hosted at a Vallejo business (likely held during business hours)\*
- Invitations to special community meetings and events, such as community meetings on new development projects or events by Vallejo's economic development partners

These activities will be noticed as special meetings according to the Brown Act and open to the public.

#### Frequency of Meetings

Per Council direction, the EVC will have a noticed meeting at least quarterly. Within a six-month period, staff is aiming to have two Wednesday night meetings in Council Chambers and one meeting that is either a business walk or a tour / meeting at a Vallejo business.
