14. Old Business

a. Possible Reallocation of FY 2006/2007 CDBG Funds

The 100 Block of Benson Avenue Public Improvement Project in Vallejo Heights requires additional funding in order to be completed. The current approved construction budget for Benson Avenue is \$447,500. At a special Commission meeting in April, staff recommended that the City not proceed with this project, given that sufficient funding is not available to complete all of the needed improvements. Staff further recommended that the funding currently allocated to Benson Avenue, and other unallocated funds, instead be allocated to other activities. The total amount of unallocated funds available at this time is \$282,964.

At the April meeting, after receiving public input and considering this item, the Commission voted unanimously, 8-0-0, to defer a decision on funding for the Benson Avenue Project, and the possible use of unallocated funds. The Commission delayed action in order first to ascertain whether the scope of work for Benson Avenue may be revised and completed, using available funding.

Staff has reviewed the scope of work, and determined that it can be reduced, while still providing several needed improvements. Staff recommends that \$282,964 in unallocated funds be allocated to Benson Avenue. If approved, the revised budget for the project will be \$730,464.
