A. UPDATE ON STATUS OF FLOSDEN ACRES FUTURE IMPROVEMENTS.

At its June 13, 2007 regular meeting, the Commission received a request from Ms. Earnestine Lawson on behalf of a community group in the Country Club Crest neighborhood for Flosden Acres Redevelopment Area funds to accomplish neighborhood improvements. Staff will provide an update on the status of addressing the improvement project requests.

B. U. S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT'S (HUD) APPROVAL OF THE CITY OF VALLEJO HOUSING AUTHORITY'S ANNUAL, 2007 PUBLIC HOUSING AUTHORITY PLAN SUBMISSION.

The U.S. Department of Housing and Urban Development (HUD) requires Housing Authorities to prepare Five-Year Plans and Annual Plans for its Housing Choice Voucher (Section 8 Existing) Program. The City of Vallejo Housing Authority (VHA), with a Fiscal Year (FY) from July 1 to June 30, adopted its most recent Five-Year Plan for the City of Vallejo in 2005. The current Five-Year Plan covers the period beginning July 1, 2005, and ending June 30, 2010. Staff has amended the current Plan to include the Avian Glen Apartments.

<u>RECOMMENDATION</u>: Receive the HUD approved amended City of Vallejo Housing Authority Annual Plan.

C. RESPONSE LETTER TO HUD REGARDING THE VALLEJO HOUSING AUTHORITY'S APPLICATION FOR PROJECT BASED VOUCHER (PBV) ASSISTANCE AT AVIAN GLEN APARTMENTS.

The Housing Authority applied to HUD for Project Based Voucher assistance for the Avian Glen Apartments. Staff will report on the progress of the HA request.
