a. FY 2012/2013 CDBG and HOME Program Funding Allocations

In 2011, the City allocated FY 2011/2012 and estimated FY 2012/2013 CDBG and HOME Program funds to several projects and activities. This effort was assisted by a Commission Ad Hoc Committee on Requests for Funding (Burnett, Chair; Bryant), which received public presentations from non-profit agencies, and considered funding proposals submitted for FY 2011/2012 and FY 2012/2013. HUD has notified the City that in FY 2012/2013, (which begins July 1, 2012) its CDBG and HOME Program funding allocations will be significantly reduced. Staff recommends that the Commission re-establish an Ad Hoc Committee to develop, with staff, revised funding recommendations for the Commission's action not later than April 5, 2012.

Recommendation: Create an Ad Hoc Committee, (consisting of no more than three Commissioners)
