Election of Officers

Section 1.01 of the Commission's By-Laws state that the Commission shall elect a Chair and Vice Chair at the first regular meeting of the new fiscal year, (starting July 1). The terms of Commissioner Urick as Chair, and Commissioner Brown as Vice Chair, have expired. Commissioner Urick resigned from the Commission in June, 2012. Commissioner Brown is eligible to serve another term. The Brown Act expressly prohibits secret ballots.

Recommendation: Nominate and elect a Chair and Vice Chair.

Recommendation: After conducting a public hearing, by motion, recommend approval of the FY 2011/2012 CAPER by the City Council.
