  - a. Proposed Fiscal Year (FY) 2013/2014 Action Plan, and Proposed FY 2013/2014 and Estimated FY 2014/2015 Community Development Block Grant (CDBG) Program and HOME Investment Partnerships Program Funding Allocations

For each year of the City's Five Year Consolidated Plan, the City is required to submit an "Action Plan" to the Department of Housing and Urban Development, which this year will include the City's proposed allocation of CDBG Program and HOME Program funds in FY 2013/2014. The FY 2013/2014 Action Plan is due to HUD by May 15, 2013.

In October, 2012, the City Council adopted a two-year funding cycle for the allocation of CDBG Program and HOME Program funds in FY 2013/2014 and FY 2014/2015. The City estimates that in FY 2013/2014, it will receive \$891,822 in CDBG Program funds, and \$547,301 in HOME Program funds.

In November, 2012, the Commission created an Ad Hoc Committee on Funding Requests, (Brown, Chair; Parker) to develop, with staff, funding recommendations for the Commission's action by not later than April 4, 2013. On March 5, 2013, staff met with the Ad Hoc Committee for this purpose. Accordingly, staff is presenting the FY 2013/2014 and FY 2014/2015 CDBG

Program and HOME Program funding recommendations of the Ad Hoc Committee, and staff. The Committee and staff are in agreement on the recommendations. The draft FY 2013/2014 Action Plan is enclosed with the agenda as Attachment A. For more information, a staff report will be provided under separate cover.

Recommendation: After holding a public hearing, by motion, recommend approval by the City Council of the FY 2013/2014 Action Plan, including FY 2013/2014 CDBG Program and HOME Program funding recommendations, and estimated FY 2014/2015 CDBG Program and HOME Program funding recommendations, as presented by a Commission Ad Hoc Committee, and staff.
