#### 4. Approval of Agenda

Section 1.01 of the Commission's By-Laws state that the Commission shall elect a Chair and Vice Chair at the first regular meeting of the new fiscal year, (starting July 1), who shall serve for one year. Section 1.04 further states that no Commissioner shall serve more than two one-year consecutive terms as Chair and Vice Chair.

Commissioner Brown is eligible to serve another term as Chair. Commissioner Parker is eligible to serve another term as Vice Chair. The Brown Act expressly prohibits secret ballots.

  - a. Vallejo Housing Collaborative (VHC) Permanent Supportive Housing Project
    - Recommendation: By motion, recommend that the Housing Authority and the City Council authorize the Executive Director/City Manager or his designee to enter into a residual receipts Loan Agreement by and between the Vallejo Housing Authority and VHC in the amount of \$900,000; and a residual receipts HOME Investment Partnerships Program Loan Agreement by and between the City of Vallejo and VHC in the amount of \$100,000; authorizing VHC to create up to twelve units of permanent supportive housing for homeless families; and require the establishment of a three-year operating deficit reserve in an amount not to exceed \$121,867 from the \$1 million allocation; and authorize the

Executive Director/City Manager to make minor amendments to the Loan Agreements with the approval of the City Attorney.

b. Coventry Homes (Mini and Stanford Drives), and Sonoma Estates (Sonoma and McLane), Homeownership Project
