a. Proposed Consolidated Plan Amendments

In May, 2010, the City adopted a Consolidated Plan, which includes the period beginning July 1, 2010, and ending June 30, 2015. As a condition of receiving certain Federal funding, this plan is a document required by the U. S. Department of Housing and Urban Development (HUD) which addresses community development and affordable housing needs in Vallejo. The Consolidated Plan has prioritized these needs and, during the life of the Plan, identifies the estimated amounts and sources of funding that will be expended on an annual basis by the City and other entities on various community development and housing activities.

Staff is proposing amendments to the City's Consolidated Plan. For more information, a staff report is enclosed with the agenda.
