The Working Library: Clifford Burke and Fine Printing showcases selected works from Cranium Press, founded by Burke in 1967, along with books that informed and inspired his distinguished career as poet, printer, and publisher. Burke considers these books technical, historical, and inspirational mileposts as he developed his skills and vision within the California book tradition. The exhibition also includes personal letters, news articles, and ephemera that reveal his significant contribution to the San Francisco printing community.

Cranium Press operated from the late 1960s through the '70s, attaining a reputation for the beauty and originality of its productions of San Francisco Beat and Haight-Ashbury poets. It was an influential meeting place for a new generation of printers; poets, artists, and novice printers met there regularly to create broadsides and chapbooks. Clifford, a poet himself, became renowned as a craftsman, teacher, and commentator on the typographic book. His *Printing Poetry* remains one of the classics in the literature of bookmaking. His most recent essay, *The Working Library*, published in *The Book Club of California Quarterly* and as a keepsake for this exhibition, is a tribute to the poets, printers, publishers, book artisans, teachers, librarians, and others who contributed to his education.

The Cranium Press Working Library is now housed at the Book Club of California Albert Sperisen Special Collections Library. It was compiled, used, and occasionally loaned out by Clifford over the four decades he was involved in bookmaking. It has been Burke's intent that the collection serve other young printers as they did him. It has been his hope that similar collections from other California book people could eventually be added, along with the stories of their educations, traditions, inspirations, and accomplishments. The vision in putting this exhibition together has been to launch a series of talks by other practioners of the book arts about the ideas, events, people, and books that informed their work. Such a series, with presentations by bookbinders, papermakers, calligraphers, type designers, printers, writers, artists, and publishers, would build and preserve the legacy of California's extraordinary book community.

NOTES:

The McCune Collection is entrusted to the City of Vallejo and thus belongs to all citizens of Vallejo. Therefore the McCune Commission places a high priority on making the Collection available for the public to enjoy. Public Outreach Programs focus on 6 annual lectures, participation in monthly Art Walks and regular docent hours. These events are free and the primary means by which the Commission makes the Collection available to the public.

To the Attention of The McCune Collection Board of Commissioners:

Proposal: The McCune Collection Printing Society Subcommittee

This is a proposal establishing the need for the responsible and organized use of the collection's press and detailing a plan to bring into being.

Purpose/Aim

The McCune collection, as valuable cultural resource, has a number of opportunities to connect with the residents of Vallejo in ways that create a larger community and enrich lives, while also bringing more attention to The McCune, its collection, and mission. A clearly stated part of that mission is the use of the Albion Press to both encourage the community of printers and keep the art of printing alive from generation to generation. The Press should be operated, and the commission should form a subcommittee dedicated to seeing that this happens responsibly.

Plan

Regarding the need:

- The McCune collection has been the home to a society of printers in the past which was fondly regarded and is now missed.
- One of the clearly stated goals of the McCune Collection is to see that press be operated in order to honor Dr. McCune's memory and to preserve the art of printing, book binding and the culture of the hand-made book.

Regarding the particulars:

- Focus: The subcommittee would be composed of willing commissioners and volunteers and would meet with the goal of drafting and submitting a plan to the city for establishing an organization under the authority of the commission to use the Press.
- Goals: The short-term, immediate goal would simply be to draft a plan for presentation to the commission for consideration. This plan would address the following concerns:

A) Principles, procedures and protocols for use of the press, including but not limited to an authorized users list, a detailed plan for the clean and safe use of the facility and equipment, the need for training, possible costs, etc.

B) The creation of a community-facing organization dedicated to using the press, it's make-up, goals, and functioning.

Conclusion:

The care and use of the press is a clearly stated part of the McCune Commission's mission, and at this time, we are simply failing to fulfill this duty. Not only will the It will raise our profile in the community, and increase interest in the collection. Therefore, I move that a subcommittee be formed for the purpose of drafting a plan to use the press and to present this plan to the commission.
