

Congratulations <u>Team Delegates for on</u> the work you have done thus far to improve Vallejo and enhance your civic obligations! You are in the home stretch! As you prepare for campaigning and <u>Voting Expos</u>, please adhere to the following guidelines:

Trifold Poster Instructions & Guidelines:

- **★** Expo Workshop
 - Meet and greet your fellow team delegates on October 10 from 11 a.m. to 1 p.m. at Kyles Temple, 912 Florida Street.
 - Delegates are invited to make their expo poster boards with their committees. A trifold board and craft items will be made available.
 - Lunch will be served.
- Your trifold display each board MUST contain the following:
 - Description of project, including a map or location of project, how the project responds to the community needs, estimated costs, challenges, and implementing partner.
 - Due to safety, space and lack of wifi at voting locations, technology is NOT permitted (i.e.: no laptops, projectors, or other forms of media).
 - Displays will only occupy one side of the trifold board.
 - Objects may exceed the height of the trifold board.
 - Decorative items or information relevant to the project proposal will be allowed in front of the trifold board as long as they affix to the board in some fashion.
 - In the interest of fairness, please limit the amount of financial resources spent on promoting your project.
 - > No takeaways, such as handouts, candy or trinkets.

Campaign & Community Outreach Guidelines:

- Negative speech about other <u>Budget Delegates committees</u> or <u>other project proposals</u> is prohibited.
- Prior to October 23, a Acceptable methods of campaigning include:
 - The use of flyers, email, social media, videos, door-knocking, and phone calls.
 - ➤ All materials **must include** the following statement:

"City of Vallejo's Participatory Budgeting (PB) program gives residents the opportunity to have a voice in how their tax dollars are spent. This project is one of many being developed through the PB process. The dates of the Participatory Budgeting vote are October 24April 1

November 2 April 30, 2017. For more information, please visit phyallejo.comorg."

- After October 23, From April 1 through April 30, 2017 there will be no campaigning at sites in the community, while voting is occurring at satellite sites or in voting areas.
- When promoting a project, you must provide general information that will help the voters understand the PB process and vote.

- Presentations and community outreach made by you or any non-delegate representatives, such as but not limited to speaking to community groups, media interviews, or PSAs, must promote PB as a whole in addition to your project, by printing the required statement on all materials (see campaign guidelines for statement).

PARTICIPATORY BUDGETING STEERING COMMITTEE RESOLUTION OF JANUARY 19, 2017

A RESOLUTION OF THE PARTICIPATORY BUDGETING STEERING COMMITTEE RECOMMENDING THE REALLOCATION OF UNSPENT FUNDS FROM INACTIVE PB PROJECTS

WHEREAS, on July 17, 2012, the City Council of the City of Vallejo created a Community Steering Committee via Resolution 12-108 N.C, and appointed representatives from civic organizations and their representatives to be an advisory committee to the Council in its proposal regarding the PB process and structure; and

WHEREAS, upon the completion of the Participatory Budgeting (PB) election process after Cycle 1 (2013), Cycle 2 (2014) and Cycle 3 (2015), the results were presented to the City Council and projects selected by the public were allocated Measure B funding by City Council; and

WHEREAS, pursuant to Resolution No. 13-09 N.C., the Council allocated \$170,000 in Measure B funding for the Cycle 1 PB Project "Light Up Vallejo"; and

WHEREAS, the Light Up Vallejo project partially completed its goals resulting in \$137,974 in unspent funding; and

WHEREAS, pursuant to Resolution No. 14-128 N.C., the Council allocated \$18,000 in Measure B funding for the Cycle 2 Project "Improving School Meals"; and

WHEREAS, the Improving School Meals project partially completed its goals resulting in \$10,665 in unspent funding.

WHEREAS, pursuant to Resolution No.16-049 N.C., the Council allocated \$82,000 in Measure B funding to extend the Cycle 2 PB Project "Summer Youth Employment and Internship Program"; and

WHEREAS, the Summer Youth Employment and Internship Program partially completed its goals resulting in \$25,991 in unspent funding; and

WHEREAS, pursuant to Resolution No. 15-143 N.C., the Council allocated \$50,000 in Measure B funding for the Cycle 3 Project "Vallejo Firefighter Youth Academy"; and

WHEREAS, the Vallejo Firefighter Youth Academy successfully completed its stated goals under-budget, resulting in \$4,930 in unused funding; and

NOW THEREFORE BE IT RESOLVED that the PB Steering Committee recommends to City Council to reallocate unused project funding as follows:

- 1) Close out Cycle 1 "Light Up Vallejo" project and reallocate \$137,974 in unused funding to the Cycle 2 "Help the Homeless" project
- 2) Reallocate \$10,665 in unused funding from the Cycle 2 "Improving School Meals" project to the Cycle 2 "Help the Homeless" project
- 3) Reallocate \$25,991 in unused funding from the Cycle 2 "Summer Youth Employment and Internship Program," to the Cycle 3 "Vallejo Firefighter Youth Academy."

Adopted by the Participatory Budgeting Steering Committee at a Special Meeting held on January 19, 2017.
