1.Update on Implementation of a Payment Installment Plan – Staff reported that Code Enforcement has successfully completed its trial run with its first Board-approved installment payment arrangement on a Notice of Violation. Vice-Chairperson Madeiros requested that staff include the fee waiver or some documentation showing whether the Board needs to provide a payment plan to the appellant. The Board Members have also requested that a "matrix" or form is created to show the appellant their choices, for uniformity or consistency reasons, including "failure to pay" language. An update will be provided at the September 22nd, 2016 meeting.

PAYMENT SCHEDULE - RULES AND MATRIX

Vallejo Municipal Code Section 1.15.150 authorizes the City, at its discretion, to pursue any and all legal and equitable remedies for the recovery of fines and/or associated administrative charges owed to the city. The amount of any unpaid administrative charges and/or abatement costs including incidental costs may be made a lien on the real property on which the violation occurred and may constitute as a special assessment added to the ordinary secured property taxes. Please refer to the table below for details on the fines and penalties.

Vallejo Municipal Code Section 7.54.150 authorizes the City, at its discretion, to pursue any and all legal and equitable remedies for the recovery of unpaid administrative charges. The amount of any unpaid administrative charges and/or abatement costs including incidental costs may be made a lien on the real property on which the violation occurred and may constitute as a special assessment added to the ordinary secured property taxes.

In addition, the lien will remain on the property title until the full amount has been paid to the City of Vallejo.

A copy of the invoice should be included with the payment. If paying by check or money order, please ensure the case number, [CASE_NO] is written on the check or money order and make it payable to the City of Vallejo.

*If applicable, lien releases will be prepared after full payment and may be picked up from our office at 2 Florida Street, Vallejo, CA or mailed (postage fees apply).

You will need to have the lien releases recorded at the Solano County Recorder's Office (their office charges a filing fee for EACH document number to be released).

Please note that this payment installment plan is a privilege granted by the City of Vallejo to the appellant/applicant and may be discontinued/revoked at any time. The payment installment plan can only be granted by Code Enforcement management if the applicant is within their 30-day appeal timeframe, or granted during a scheduled hearing with the Code Enforcement Appeals Board.
