The City of Vallejo is required by the U. S. Department of Housing and Urban Development (HUD) to prepare a Consolidated Plan. The Consolidated Plan concerns housing and community development needs. The City's next Consolidated Plan will include the period beginning July 1, 2010, and ending June 30, 2015. The City's deadline for submitting the Consolidated Plan to HUD is May 14, 2010.

Before a draft of the Consolidated Plan is prepared, the City is required to hold at least one public meeting to gather information and receive comments on housing and community development needs in Vallejo. This public hearing will also provide an opportunity for residents and other interested parties to comment on how the City's Federal Community Development Block Grant (CDBG) Program and HOME Investment Partnerships Program funds may be used in Fiscal Year (FY) 2010/2011.

# a. Section Eight Management Assessment Program (SEMAP)

SEMAP is designed to measure the performance of the Housing Authority. SEMAP qualifies performance based on fourteen management indicators. The Housing Authority is required to submit a self-certification to HUD annually. The certification is then evaluated and verified by HUD, and by an independent auditor. The final SEMAP score for FY 2008/2009 is 93 percent, which qualifies the Vallejo Housing Authority as a "High Performer."

# b. <u>Proposed Revisions to Vallejo Housing Authority Administrative Plan Chapters</u> Two, Six, Nine, and Thirteen

The Housing Authority's Administrative Plan contains mandatory HUD regulations, as well as local policy decisions. HUD provides regulatory language giving local jurisdictions the discretion to formulate certain policies, which shall be codified in the Administrative Plan. Any changes to the Plan must be approved by the Housing Authority Board, and provided to HUD. Staff is recommending changes to Chapters Two, Six, Nine, and Thirteen of the

Administrative Plan.

Recommendation: Review the proposed changes to Chapters Two, Six,

adopt a Resolution approving the revised chapters.

c. Ad Hoc Committee on Requests for Federal Fiscal Year (FY) 2010/2011
Community Development Block Grant (CDBG) Program and HOME Investment
Partnerships Program Funding

In December 2009, the City issued a Request for Proposals to non-profit housing and social service agencies for the use of the City's CDBG and HOME Program funds in FY 2010/2011, (July 1, 2010 through June 30, 2011). Proposals are due not later than 12:00 p. m. (PST) on Friday, January 8, 2010.

Staff recommends that the schedule for the selection of non-profit agency proposals recommended for funding by the Commission to the City Council include presentations to an Ad Hoc Committee of the Commission, and City staff. Staff further recommends that the proposed schedule commence not earlier than January 11, 2010, and be completed not later than February 5, 2010.

After considering these proposals, the Ad Hoc Committee may recommend selected non-profit agencies to the Commission by or before April 1, 2010.

Recommendation: Establish an Ad Hoc Committee on CDBG and HOME

Program Request for Proposals. Determine the members of the Committee who will serve on the Ad Hoc Committee. In accordance with the Brown Act, the Chair will appoint no more than three Commissioners to the Ad Hoc Committee.

#### d. Election of Chair

On November 5, 2009, the Commission nominated Commissioner Urick to serve as Chair, subject to ratification by the City Council. On November 17, 2009, the City Council appointed Commissioner Urick Chair of the Commission. Pursuant to the Commission's Ordinance, the current Chair's term expires December 31, 2009. Commissioner Urick is eligible to be elected to another term.

The Brown Act expressly prohibits secret ballots.
